- Individualized Educational Plan (IEP) or 504 Plan (if applicable)

- Most recent report card or transcript
- Most recent state testing results

FORT IRWIN MIDDLE SCHOOL PLACEMENT ASSESSMENT TESTING

Please bring your student to Centralized Enrollment

Students who are new to Ft. Irwin Middle School will be assessed for grade level readiness in both English Language Arts and Mathematics from 7:30am to 2:00pm during the Centralized Enrollment days. If you are unable to test during Centralized Enrollment, testing days will be made available at Fort Irwin Middle School. Please contact the school @ 760-386-1133 to schedule an appointment.



In addition to enrolling all your children in one location, you will be able to arrange:

- Transportation for your children
- Forms to administer medication needed at school
- Meet with School Psychologist if your student is in Special Education
- Pick up paperwork to volunteer at your child's school
- Pick up applications for any vacant classified positions, i.e., Noon Duty Aide, Cafeteria Help, substitute jobs such as Clerical, Cafeteria and Custodial
- Receive information on parent organizations for your child's school
- Receive information on orientation and tour of your child's school
- Schedule appointments with the principal at the time of enrollment for Inter-District Transfers
- Meet with the District Nurse if your student has any health concerns or specialized procedures i.e.; EPI Pen, seizures, diabetes, etc.
- Obtain physical forms for sports programs (Middle/High School)
- National School Lunch Program Application will be available

IMMUNIZATIONS: California Requirements

Parents: Children need to have these immunizations **BEFORE** they can begin school!

Physicals



- Kindergarten physicals must be dated within 6 months of 1st day of school
- First grade physicals must be dated within 18 months of 1st day of school
- Sports physicals must be dated within 1 year prior to participating in practices or games

Oral Health Screenings

- Kindergarten: Date will be accepted up to 12 months' prior of 1st day of school year
- First grade: If child did not attend kindergarten, they must have screening. Date will be accepted 12 months' prior of school year or first time enrolled in school



Entry Requirements by Age and Grade:

Vaccine	4–6 Years Old Elementary School at Transitional–Kindergarten/ Kindergarten and Above	7–17 Years Old Elementary or Secondary School	7 th Grade *
Polio (OPV or IPV)	4 doses (3 doses OK if one was given on or after 4th birthday)	4 doses (3 doses OK if one was given on or after 2nd birthday)	
Diphtheria, Tetanus, and Pertussis (DTaP, DTP, DT, or Tdap)	5 doses of DTaP, DTP, or DT (4 doses OK if one was given on or after 4th birthday)	4 doses of DTaP, DTP, DT, Tdap, or Td (3 doses OK if last dose was given on or after 2nd birthday. At least one dose must be Tdap or DTaP/DTP given on or after 7th birthday for all 7th–12th graders.)	1 dose of Tdap (Or DTP/DTaP given on or after the 7th birthday.)
Measles, Mumps, and Rubella (MMR or MMR–V)	2 doses (Both doses given on or after 1st birthday. Only one dose of mumps and rubella vaccines are required if given separately.)	1 dose (Dose given on or after 1st birthday. Mumps vaccine is not required if given separately.)	2 doses of MMR or any measles–containing vaccine (Both doses given on or after 1 st birthday.)
Hepatitis B (Hep B or HBV)	3 doses		
Varicella (chickenpox, VAR, MMR–V or VZV)	1 dose	1 dose for ages 7–12 years. 2 doses for ages 13–17 years.	

WHY YOUR CHILD NEEDS SHOTS:

The California School Immunization Law requires that children be up to date on their immunizations (shots) to attend school. Diseases like measles spread quickly, so children need to be protected before they enter. California schools are required to check immunization records for all new student admissions at Kindergarten or Transitional Kindergarten **through** 12th grade and all students advancing to 7th grade before entry.

THE LAW:

Health and Safety code, Division 105, Part 2, Chapter 1, Sections 120325-120380; California Code of Regulations, Title 17, Division 1, Chapter 4, Subchapter 8, Sections 6000-6075

WHAT YOU WILL NEED FOR ADMISSION:

To attend school, your child's Immunization Record must show the date for each required shot above. If you do not have an Immunization Record, or your child has not received all required shots, call your doctor now for an appointment.

If a licensed physician determines a vaccine should not be given to your child because of medical reasons, submit a written statement from the physician for a **medical exemption** for the missing shot(s), including the duration of the medical exemption.

A personal beliefs exemption is no longer an option for entry into school; however, a valid personal beliefs exemption filed with a school before January 1, 2016 is valid until entry into the next grade span (7th through 12th grade). Valid personal beliefs exemptions may be transferred between schools in California. For complete details, visit ShotsForSchool.org.

You must also submit an immunization record for all required shots not exempted.
