### Graduation

- Waiving required courses for graduation if similar course work was completed at another school
- Flexibility in accepting sending state exit or end-of-course exams, national achievement tests, or alternative testing in lieu of testing requirements for graduation in the receiving state
- Allowing students to receive diploma from the sending school as an alternative to accommodations for exit exams and graduation requirements the student does not have time to meet
- Should a waiver not be granted, the District shall provide an alternative means for acquiring course work, so graduation may occur on time

### Students Not Covered Under the compact

- Inactive members of the Naitonal Guard and Reserves
- Members now retired not covered under the compact
- Veterans not covered under the compact
- Other Department of Defense personnel, federal agency civilians and contract employees not defined as active duty
- Members other than the uniformed personnel of NOAA and USPHS



## Students Covered Under the Compact

The Military Interstate Compact is designed to provide uniform treatment of military connected students as they make frequent relocations in those member states. The following children are covered under the compact:

- Active duty members of the uniformed services, including members of the National Guard and Reserve on active duty orders
- Members or veterans who are medically discharged or retired for one year
- Members who die on active duty, for a period of one year after death
- Uniformed members of the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA), and United States Public Health Services (USPHS)

## Placement and Attendance

- Receiving state will initially honor placement in courses or programs based on previous placement
- Receiving state may perform evaluation to ensure appropriate placement and continued flexibility to waive course or program prerequisites if similar course work has been completed in another school
- Flexibility to excuse absences due to deployment\*



## Educational Records

- Parents can receive a copy of unofficial records
- Receiving school must accept unofficial records and enroll and place student pending receipt of official records
- Sending school must send official records within ten (10) business days
- Parent is given 30 days from enrollment to obtain required immunizations or start the series of immunizations
- Kindergarten--student must have been enrolled and attended class in sending state/country in order to assure continued attendance in Kindergarten in receiving state
- Students who have satisfactorily completed a grade level in the sending state shall be eligible for enrollment in the receiving state regardless of age

<u>Deployment</u> is defined as the period of one (1) month prior to the service members' departure from their home station on military orders through six (6) months after return to their home station.
